## 1.0 RATIONALE

- 1.1 It is the policy of Bluewater District School Board to permit private music instruction to day school students, in accordance with the Education Act Section 21 (2)(e), and subject to the following procedure.
- 1.2 Bluewater District School Board is committed to ensuring that students have every possible opportunity for growth and development. At the same time the board is committed to using space and equipment within the schools to the best advantage.

## 2.0 PROCEDURE

- 2.1 Private music instruction may be provided to students at Bluewater District schools subject to consultation with the School Council and the approval of the principal.
- 2.2 Scheduling of the instructional period will be such that there is no interference or disruption to the regular classroom program. Whenever possible, instruction will occur outside of the classroom teaching timetable.
- 2.3 Instruction shall be consistent with the regular school program.
- 2.4 Each instructor must present the appropriate qualifications upon the request of the principal.
- 2.5 Each instructor is required to complete form AF 5901 "Permit for the Use of Schools".
- 2.6 Each instructor is required to provide proof of liability insurance in the amount of two million dollars, noting Bluewater District School Board as an additional insured.
- 2.7 Private music instructors will be considered service providers and School Administrators will be required to comply with administrative procedure AP 7382-D "Criminal Background Check Service Providers". This procedure requires that administrators update Human Resources Services with the names, addresses, phone numbers and contact names of new service providers. Administrators are to obtain a criminal background check for all new service providers, or an offence declaration for returning service providers, on an annual basis/
- 2.8 Appropriate instructional space and a piano or other instruments will be provided without cost to the instructor, if required, subject to their availability. Piano tuning is the responsibility of the instructor.

- 2.9 In the event that more than one suitable instructor is available and interested in providing private music instruction, the principal will endeavour to ensure that the available time and resources are shared equitably.
- 2.10 The school will not be responsible for the collection of any fees.
- 2.11 The instructor shall be responsible to the principal for the conduct of students in the music program while in the school.
- 2.12 Advertising and/or recruitment for the lessons will remain as the responsibility of the instructor.
- 2.13 Instruction is to be provided for the students enrolled at the school. Instruction may be provided for other students at the discretion of the principal.
- 2.14 Instructors who wish to access the space and equipment for instruction, beyond the regular school day, may do so under board policy BP 5901-D "Community Use of Schools". A rental fee is applicable in these cases.
- 2.15 Bluewater District School Board reserves the right to alter the arrangements for this program in consultation with the principal and the School Council.
