### Question 1:

The Play structure requirements on page 12 of the RFQ documents asks for a side by side slide that is accessible by ramp (not stairs)

Ramps require a ratio of 1:12. Meaning you need a 12ft ramp to gain 1ft (12inches of height) In order to provide a slide that is accessible by ramp, we would require at least 3 ramps to get to a 3ft height off the ground. The site dimensions and budget do not permit this size of structure. It also states no small slides – so although we could do a 3ft slide, it would be considered a small slide.

Is it possible to exclude the requirement of a ramped structure. We can provide a structure with a transfer station with accessible stairs and include accessible ground level play.

### Answer 1:

Article 2.4 section c states that "the primary play structure should include the following features or features similar to those described below:". As per the definition included on page 10, should "means recommended/suggested/preferred but not mandatory." The submission presented to the Board should be completed based on the best design aligning with the budget and timelines listed while including some or all of the requested features as feasible.
